NOTICE OF APPEAL

Appellants Thomas E. Meacham, Teri Namtvedt, and Kirk Duncan, by and through their counsel Thomas E. Meacham, Attorney at Law, herewith files their Notice of Appeal from the Denial of Request for Reconsideration signed by Commissioner Corri A. Feige and dated February 10, 2020, and the Final Decision dated January 13, 2020, recommended by Ricky Gease, Director of the Alaska Division of Parks & Outdoor Recreation and signed by Commissioner Corri A. Feige on that date.

This appeal is filed pursuant to Alaska Appellate Rule 602(a)(2).

This Notice of Appeal is accompanied by the Appellants' Cost Bond on Appeal in the amount of \$750.00 pursuant to Appellate Rules 602(e) and 204(c)(1), by the appellants' filing fee in the amount of \$250.00 pursuant to Appellate Rule 602(c)(1)(B) and Administrative Rule 9(b)(1), and by the appellants' Statement of Points on Appeal pursuant to Appellate Rule 602(c)(1)(A).

Pursuant to Appellate Rule 602(c)(1)(A), the following information is provided:

1. The parties taking the appeal: The parties taking this appeal are individuals Thomas E. Meacham, Teri Namtvedt, and Kirk Duncan, represented in this appeal by Thomas E. Meacham, Attorney at Law, Alaska Bar No. 7111032. The appellants' address is c/o Thomas E. Meacham, Attorney at Law, 9500 Prospect Drive, Anchorage, Alaska 99507.

Each of the appellants participated in the administrative process and the public comment periods that preceded the issuance of the Final Decision dated January 13, 2020, and the Denial of Request for Reconsideration dated February 10, 2020.

2. The agency appealed from: The agency decisions appealed from are (1) the Final Decision dated January 13, 2020, that was recommended by Ricky Gease, Director of the Alaska Division of Parks & Outdoor Recreation and approved by Corri A. Feige, Commissioner of the Department of Natural Resources, both acting on that date; and (2) the Letter dated February 10, 2020, signed by Commissioner Feige on that date, which Letter denied the appellants' timely requests that Commissioner Feige grant reconsideration of her January 13, 2020 Final Decision pursuant to 11 AAC 02.030(a).

Copies of the Final Decision dated January 13, 2020, and the Letter denying reconsideration dated February 10, 2020, accompany this Notice of Appeal as the appellants' Exhibits 1 and 2, respectively.

3. The name of the court to which the appeal is taken: The court to which this appeal is taken is the Alaska Superior Court, Third Judicial District, sitting in Anchorage, Alaska as an appellate court hearing appeals from final administrative decisions of State of Alaska agencies pursuant to Appellate Rules 601 through 612.

4. Proof of service on other parties in the administrative proceeding: A certificate of service evidencing service by Certified Mail upon the Commissioner of the Alaska

Department of Natural Resources, the Director of the Alaska Division of Parks & Outdoor Recreation, and the Office of the Attorney General, State of Alaska, in both Juneau, Alaska and Anchorage, Alaska, is filed with this Notice of Appeal.
